Grant originated in the 88th Texas Legislature

- The 88th Texas Legislature appropriated \$20 million across the biennium (\$10M for School Year 2024-2025 and \$10M for School Year 2025-2026).
- There is no set minimum or maximum award set per grantee.
- There is no set number of grantees.





Who is eligible to apply?

- All Texas public schools and open-enrollment charter schools are eligible to apply for grant funding.
- LEAs may apply individually or in collaboration with other districts or open-enrollment charter schools.
- Prioritization of funding is given to collaborative applications.






Purpose of the Grant



To increase the LEA's capacity to implement innovative programs that effectively serve students with autism ages three through 21.



To result in effective, scalable models that can be replicated in other areas of the state.

- Evidence-based practices
- Data collection on student achievement and improvement
- Parental support and collaboration
- Use of technology, which may include interactive technology
- Meaningful inclusion
- Ability to replicate the program for students statewide

May 31, 2024 — Grant award application for selected applicants *closes* on the TEA System.

May 31, 2024 — Grant begin date.
